WHY NANOTECHNOLOGIES?

Nanotechnologies are predicted to be a main driver of technology and business in this century and hold the promise of higher performance materials, intelligent systems and new production methods with significant impact on all aspects of society. However, nanotechnologies have also raised concerns on potential health risks, environmental hazards and wider social and ethical issues regarding their possible unforeseen long-term consequences.

In this view, a Responsible Research and Innovation (RRI) approach is now adopted by the EU and its partners, to initiate dialogues about the use of nanotechnologies.

NANOTECHNOLOGY IS AN EMERGING TECHNOLOGY THAT INVOLVES THE DESIGN, CHARACTERIZATION, PRODUCTION, AND APPLICATION OF STRUCTURES, DEVICES, AND SYSTEMS BY CONTROLLED MANIPULATION OF SIZE AND SHAPE AT THE NANOMETER SCALE. IT IS ALREADY USED IN EVERY DAY PRODUCTS.

WHAT IS RESPONSIBLE RESEARCH AND INNOVATION (RRI)?

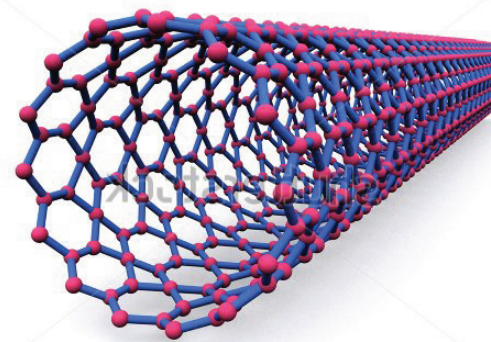
